As interdisciplinary educators and academics, we are enthusiastic proponents of stepping beyond the boundaries of your degree programme as a student – the skills you need to tackle complex problems can't all be found within the confines of a single discipline. Yunyan Huang is a second-year BSc Sociology student at LSE. She is interested in gender studies, post-colonial studies and their application in Greater China.

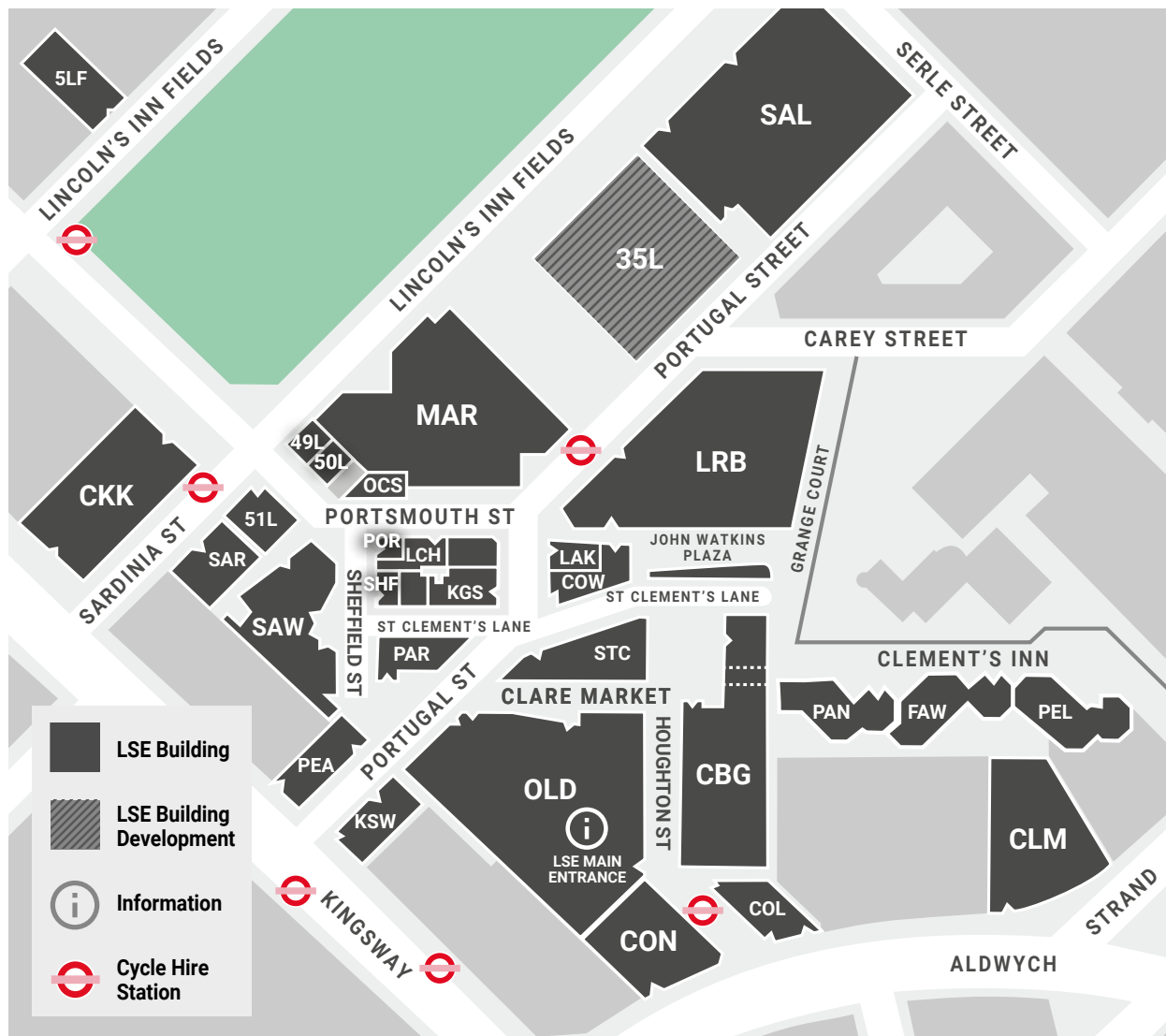
