

LSETO is the institutional archive for LSE's PhD theses. It contains full text versions of theses accepted for the qualification of Doctorate at LSE. These full text versions can be freely downloaded. By depositing your work in LSE Theses Online, you (the author(s), copyright owner or assignee), grant a non-exclusive licence to the LSE on behalf of the British Library of Political and Economic Science for the duration of applicable copyright that warrants:

- you are the owner of the copyright in the whole Work(s) (including content and layout) or are duly authorised by the owner(s), or the holder(s) of these rights, and have the authority to make this agreement, and give LSE Theses Online the right to publish the Work(s) in its repository
- that the Work(s) is/are original and does not, to the best of your knowledge, infringe copyright or the other rights of any other person or party, nor does it/do they contain libellous or defamatory material
- that if the Work(s) has/have been commissioned, sponsored or supported by any organisation you represent, you have fulfilled any obligations required by such contract or agreement

A number of LSE PhD graduates have already benefitted from their work being available in the repository both in promoting their research and in obtaining publishing contracts. There are a number of advantages to making your PhD thesis available in LSETO:

- raising the visibility and reach of your research. Theses deposited in LSETO appear prominently in search engine results and are indexed by authoritative sources (eg the British Library's ETHOS and DART). Since 2012, theses have been downloaded from LSETO over 300,000 times, worldwide. Several studies also suggest that research that is available open access is more likely to be read and cited.
- providing a stable, long-term URL that you can use to promote your work, refer potential collaborators, employers and grant providers and enable and track citations and downloads of your PhD
- ensuring long-term preservation and access to your research
- satisfying the open access requirements of funding bodies, such as RCUK
- protecting against plagiarism by making a reference copy publicly available

Theses deposited in LSETO can be freely read and downloaded, but all other rights are restricted in accordance with current copyright legislation. If you would like to enable further use of your work and, we would encourage you to **select a Creative Commons licence**, which permit you to dictate further conditions under which your work can be used and shared. These licences allow you to retain copyright while allowing others to copy, distribute, and make specified use of your thesis.

There are six available licences, ranging from CC-BY, which allows others to distribute, remix, tweak, and build upon your work, even commercially, as long as they credit you for the original creation to CC-BY-NC-ND, which only permits others to download your work and

share it with others as long as they credit you, but does not allow any commercial use or reformulation.
