

### Transfer conditions for undergraduate students by department and year of study

(Updated 28/05/2024)

Departmental tutors retain the right to depart from these guidelines on a case by case basis, and if a department is full transfers will not normally be accepted.

Any student wishing to apply to transfer degree programme should complete the Request to Transfer Degree Programme form (available at <https://info.lse.ac.uk/current-students/services/programme-transfer>) and should contact their current departmental tutor as well as the departmental tutor in the department into which they wish to transfer to discuss their case.

All degree programme transfers require the approval of both the current and new academic departments.

The two remaining courses can be outside options.</li> <li>• To transfer to the BSc Politics and Economics: Students must have taken GV100, GV101, EC1A3 <u>and</u> EC1B3, MA107 and ST107. Students may be able to take some of these courses in the first year as unlisted course requests.</li> <li>• To transfer to the BSc Politics and History: GV100, GV101 and two of HY113, HY116 and HY118. Previous class teacher and academic adviser comments may also be taken into consideration.</p> <p>Two marks of 60% for specified History courses and average of 50% for the other two. Choices must fulfil all compulsory elements for Year 1, but, for BA History, one missing component may be made up as paper 8 in second year.</p>	<p>There must be a space available on the degree/year that you wish to transfer to. Quotas will not be exceeded.</p> <p>A good academic track record in your previous programme i.e. 80% + attendance record and full coursework submission. Previous class teacher and academic adviser comments may also be taken into consideration.</p> <p>Two marks of 60% for specified History courses (normally, papers 5 and 6 in the BA History degree) and average of 50% for the other two. Must fulfil Year 2 degree requirements. For the BA degree, this will mean at least papers 5 and 6, but if necessary can suspend regulations for the third History course (paper 7). This exemption was approved by former ASC when new BA was introduced. There is a cut-off date of Week 3 in the Spring term for switching to Year 3 in order to prepare for the compulsory dissertation.</p>
<b>International Relations</b>	BSc International Relations	<p>Students who wish to transfer into the second year must have taken IR100 in their first year and at least one of the following courses: IR101, HY113 or HY116. If students have not taken IR101 in their first year, then they must take this as paper 8 in second year, with suspension of regulations. If students have taken neither HY113 nor HY116 in their first year, then they must take either HY113 or HY116 as paper 8 in second year, with suspension of regulations.</p> <p>Students get an offer for second year entry conditional upon achieving one mark of 68 or higher and an aggregate mark of 252 or higher in their first year examinations.</p> <p>There must be a space available on the degree/year that you wish to transfer to.</p>	<p>We do not normally accept transfers into the third year. Students would have to have taken IR100 and either HY113 or HY116 in the first year, at least two of the 2nd year IR courses in the second year, and IR101 in either their first or second year. Transfer requests should be submitted before the beginning of the academic year and within the first two weeks of the Autumn Term at the latest. Late requests for transfer in the same academic year will normally not be considered. The Law School expects transferred students to complete the full curriculum of four full units per year in the LLB programme. NB This option is not available for international students on Tier 4 Student Visas due to Home Office rules concerning academic progression and programme transfers while studying on your visa.</p> <p>We do not take students into the second year of the LLB, with one exception listed below.</p> <p>Students from Law and Anthropology may be admitted to the second year of the LLB if they meet the general entry requirements for LLB students, and if they have completed two years in the Law and Anthropology degree with good marks.
