## White Paper Full Structure

#### 1. Introduction

What is the aspect that you are addressing? What are the relevant behavioural frameworks that are applicable? How will you explore this aspect in your paper? What broad conclusion do you reach?

#### 2. Outline

Introduce the aspect you are discussing in more detail. Which context does it manifest itself in? How has it been explored/addressed to date?

#### i. Relevant definitions

Use sources to clarify the problem and the concepts that you use to address it. This ensures your reader has full understanding of the issues you are discussing and there is no ambiguity. It also helps you narrow down the scope of your work to a specific problem that you address.

#### ii. How the problem manifests itself

Describe and explore the context of your chosen area and the implications/significance of addressing it.

#### iii. Existing literature overview

What has been done to date to address or explore this area? Is there academic literature directly addressing this area? There might not be, in which case you can draw on more tangential examples and explain their relevance in your chosen context.

#### 3. Further discussion

This is the research core of your paper. Here you put forward your solution/framework/ breakdown of the problem.

#### i. Solutions to the problem

The structure here will be unique for each topic. Use subheadings to keep your argument structured and clear.

#### ii. Ethical implications

Discuss where your framework stands in terms of ethical implications. Can your solution introduce possible distortions? This section will be different in its relevance depending on the area you are covering.

#### 4. Further relevant policy issues

Practically speaking, what are the implications of what you have just been talking about? Can your framework/intervention be applied in real life? Do your definitions align with real-world context and to what extent?

#### Possible challenges

No idea is fully practical and works perfectly in reality as it does in theory. Tell the readers what the implications might be of implementing your suggestions into practice and where it could go wrong.

#### ii. Context restrictions

Make sure you cover what the real-life context entails for the applicability of your framework. Are the motivations for stakeholders different to yours? Is there a limited understanding of behavioural science? Might there be resistance to novelty?

#### iii. Scalability limitations

Does the scale of the problem or organisation in question mean that applicability might be restricted? Would you intervention work better in a small group environment than large group? How could you overcome this if that is the case?

#### iv. Cultural limitations

Is your framework culturally universal or might there be any limitations?

#### v. Further suggestions

If you had more time, in which direction would you take your exploration of this issue? If a large behavioural science institution picked this up, what should they focus on? Is there limited information on any areas that you would need to create a more actional plan?

#### 5. Conclusion

Briefly summarise your argument again. Include the limitations and suggestions for further research, as well as the significance of the area you chose and your findings.

#### 6. Bibliography

#### 7. Presentation

Approximately 8-10 slides aimed at key stakeholders.






# **MORNING** Project 5: Political campaigning and voter turnout
