### Important information about Federal Loan eligibility for your programme

The LSE is required to make sure that all students receiving Federal aid are registered on an eligible programme of study ([See Section 1 of the Federal Aid Guide](#)).

You have an offer or are enrolled on a 2-year programme with an option to apply to spend the 1<sup>st</sup> or 2<sup>nd</sup> year of your degree at one of the LSE's global partners. If you intend to study abroad for any part of your programme your eligibility for Title IV Federal Aid may be impacted.

#### Study at a Global Partner Institution in the United States

- ☐ If you intend to study abroad for 1 year of your programme at a School in the United States, you will become **ineligible** for Federal Aid from the LSE. Your loans for both years of your programme would have to be handled by the US School.
- ☐ If you are intending to study both years at the LSE, the programme will be eligible for Federal Aid for both years.
- ☐ You will not be allowed to change your programme pathway at the LSE if Federal Aid has been originated and disbursed in year 1 of your programme.

#### Study at a Global Partner institution not in the United States

- ☐ If you intend to study at a Global Partner institution, you will be eligible for Title IV Federal Loans for the time spent in the UK only. You may borrow private loans for your year spent abroad.
- ☐ If you are intending to study both years at the LSE, the programme will be eligible for Federal Aid for both years.
