

FAQs

- Can I get 2 bikes?
 - Yes! However both must be for your use, not family or children.

escheme

- Can I use 2 stores?
 - No, the certificate redeems in full in one transaction from one store.
- Can I top up?
 - No, this is not permissible under HMRC guidelines.
- Do I have to ride my bike every day?
 - At least 50% of the bike and/or accessories use should be for work purposes.
