#### **Terms of Reference**

On behalf of Academic Board, the Education Committee is responsible for overseeing the
education and experience of all students in order to deliver the School's Strategic Plan. The
Committee will take responsibility of behalf of the School for enhancing provision in line with
the School's educational vision and values, drawing on analysis of empirical data to inform
practice.

# Strategic Leadership

- 2. To lead on delivering the LSE 2030 implementation plans related to education and the student experience.
- 3. To draw ideas and good practice from across the School and externally, articulating an enriched menu of opportunities for enhancement across the community of faculty members, professional staff, students and alumni.
- 4. To enable the School to enhance its performance in external quality evaluations relating to education and the student experience, drawing on appropriate internal and external data sources.
- 5. To take responsibility on behalf of the School for improving educational outcomes for students, overseeing initiatives for improving educational outcomes for students from all backgrounds, including meeting our requirements and commitments under the Access and Participation Plan.

### Teaching, learning and assessment

- 6. To identify, promote and disseminate good practice across the School.
- 7. On behalf of Academic Board, to take a lead role in the development and implementation of School strategy, policy and procedure for all matters relating to the examination and assessment of students. To oversee this responsibility based on the advice of the Regulations, Policy and Standards Sub-Committee. Where a need for significant strategic change is identified, to refer matters to Academic Board for decision.
- 8. To oversee the work of the School Board of Examiners, the Graduate School Board of Examiners and the LLB Board of Examiners through the receipt of: reports on any matters arising from their monitoring of the examination and assessment processes which they deem to have wider implications for School policy or practice; and annual reports on their work during the preceding 12 months.
- 9. To oversee the development of policies for all aspects of teaching and learning innovation, delivery and assessment in the School based on the advice of the Regulations, Policy and Standards Sub-Committee and Student Experience Sub-Committee.
- 10. To endorse School regulations for degree programmes, appeals and assessment offences further to review by the Regulations, Policy and Standards Sub-Committee.

### Curriculum

11. To define, monitor and enhance School strategy, policy and procedure for the approval and review of programmes of study and their constituent courses.

12. To oversee the work of USSC, GSSC and RDSC by receiving from those sub-committees reports on any matters arising from their scrutiny of new programme and course proposals which they deem might have wider implications for School policy or procedure; and an annual report on their work during the preceding 12 months.

### Quality assurance and enhancement

- 13. On behalf of Academic Board, to define monitor and review School strategy, policies and procedures for maintaining academic standards, and assuring and enhancing the quality of its educational provision.
- 14. To be responsible for devolved quality assurance activities.
- 15. To oversee the School's relationship with external bodies, with reference to advice and guidance from relevant Education Committee Sub-Committees. This will include responsibility for: any School-wide academic review by external bodies; co-ordinating the development of School policy and procedure in compliance with national baseline regulatory requirements for quality assurance, including the Office for Students conditions of registration and the Teaching Excellence and Student Outcomes Framework, and other relevant external requirements or sector recognised standards; consideration of the School's Access and Participation Plan; oversight of compliance with the expectations of consumer law as expressed through Competition and Markets Authority guidance; and monitoring the implementation of relevant policies and procedures.
- 16. To promote quality enhancement initiatives at institutional and departmental levels.
- 17. To use the results of student surveys for quality enhancement further to advice and guidance from the Student Experience Sub-Committee.
- 18. To oversee the academic quality and standards of the School's Extended Education portfolio further to advice and guidance from the Extended Education Sub-Committee.
- 19. Members will be required to serve on panels for the periodic review of departments, though normally no member will serve on more than one review per academic year.

## Student experience and academic support

- 20. To develop, review and monitor departmental implementation of the School's academic mentoring system.
- 21. To develop and monitor student learning communities, in terms of personal guidance and advice for students, on the basis of reports from the Dean of the General Course and Global Mobility, Wardens, the Adviser to Women Students, the LSE Faith Centre and other School providers concerned with student health, wellbeing and discipline.
- 22. To provide a forum for the consideration of matters relating to students' personal security.
- 23. To monitor departmental Staff-Student Liaison Committees and the Student Consultative Fora, on the advice of the Student Experience Sub-Committee; and considering School wide issues arising from them that cannot be more appropriately considered by another School body.
- 24. To receive annual reports from residence Wardens and to advise the Director of Residential Services on 'residential life' aspects of the residential estate.

- 3. To report to the Academic Board, submit an annual report to the Board, to act on its behalf on most matters within the Committee's Terms of Reference and make recommendations to the Board on major issues of general policy affecting the academic life of the School.
- 4. To invite any person to attend its meetings to assist in the conduct of its business, including officers of the Students' Union for appropriate items.
- 5. To liaise as appropriate with the Equity, Diversity and Inclusion (EDI) office on equality and diversity issues, by means of the exchange of reports and the referral of specific issues for consideration.
- 6. To liaise with, inform, and receive reports as appropriate from other School committees, fora, and processes that consider education and student experience-related matters, for example, the annual monitoring of departments by the Directorate.
