



Dear Neighbour,

We are writing to introduce McGee as the Appointed Principal Contractor for the deconstruction and demolition works at 44 Lincoln Inn Fields (formally occupied by Cancer Research UK). McGee will be undertaking the full encapsulation of the property along Lincoln's Inn Fields, Portsmouth Street and Portugal Street. We have been working closely with the Local Authorities and the immediate stakeholders to coordinate early activities.

We have commenced the full encapsulation of the property along Lincoln's Inn Fields, Portsmouth Street and Portugal Street. Our first activities have been to construct pedestrian walkways and close off the boundary to Portsmouth Street and Portugal Street, our traffic & pedestrian management plan has been carefully planned and co-ordinated with Westminster Council and The London School of Economics and other contractors working in the area.

Our presence on site commenced on the 30th of May 2017. Our planned duration on site is into Spring of next year.

FORTHCOMING WORKS

- Erection of an external independent scaffold to Lincoln's Inn Fields,
 Portsmouth Street and Portugal Street along with loading gantry.
- Completion of fully lit hoarding around the perimeter of the site to Westminster City Council Standards.
- Deliveries to site are limited to servicing of scaffold, hoarding works and small site deliveries.
- · Setting up of internal site welfare facilities.
- Site preparatory works.
- Setting up of site monitoring equipment.
