This is the 4th of our regular newsletters to keep you informed and updated on the works taking place at 44 Lincoln Inn Fields. As part of our ongoing commitment to keeping you informed, we would like to advise you of our upcoming works on site.

October will see us focus our attentions on hard demolition works, initially removing the plant rooms and demolishing the structure to the higher levels. In the next few weeks the Holborn skyline will start to change as the building is slowly shrunk in size.

We are pleased to see the completion of our acoustic screen to the Lionel Robbins building. As just one of the noise control measures we are introducing, the acoustic screen will provide a 20dB reduction in noise levels.

The McGee Site Team would like to thank all involved in the Exchanging Places event which was held on the 27th of September organised by Mace in conjunction with the Met Police and other site contractors in the area. The event was a huge success and has highlighted the importance of cycle safety in the surrounding area. Professional Cyclist and 2016 National road race champion Adam Blythe was on hand to answer questions and offer advice about cycling safety. As a cycling style Icon Adam was also on hand to model the McGee Hi-viz slap wrap (a safety reflector band for cyclists and pedestrians) with Marc Byrne, Head of CSR and Jody Paxman, Project Manger, pictured right. The event also gave a good platform for McGee to discuss some of the existing safety features and innovations to be launched on our fleet of Iorries.

As the London School of Economics term is starting back, we recognise that the area will be very busy so we have introduced a 15mph speed limit for all McGee vehicles in the surrounding area.

The McGee Site Management team will always be happy to make themselves available should you have any queries or enquiries, especially during the first stages of demolition where perception will be at its heightened.

We realise the deconstruction phase by its nature can be disruptive for the neighbours and local environment but we would like to assure you we are doing all we can to mitigate any disruption.

We will continually be working within the bounds of our noise, dust and vibration limits as outlined within our approved Section 61 with Westminster City Council.



Site Working Hours

Our normal operational hours on site will be as follows:

Monday to Friday 08:00 – 10:00 - Noisy 10:00 – 12:00 - Normal 12:00 – 14:00 - Noisy 14:00 – 16:00 - Normal 16:00 – 18:00 - Noisy

Neighbours and local residents will be notified in advance of any changes to the agreed working hours.



UPCOMING WORKS

- Demolition of plant rooms and roof end on 7th floor.
- Continue soft stripping and asbestos removal
- Street Works are planned along Lincoln's Inn Fields for our temporary electricity.
