Site Update



Since Mace took possession of the full site on 8 March 2019 we have made significant progress. To date we have achieved the following:

- Mace site accommodation has been set up and fitted out.
- Two tower cranes have been erected.
- We have implemented a one way closure to Portsmouth Street with access only from Lincoln Inn's Fields heading south. This has been agreed, in consultation with Westminster Council.
- We have established a new pit lane in Portsmouth Street and will operate the Lincoln Inn Fields pit lane in a similar manner to McGee.
- We have set up weekly coordination meetings with the Wates team to ensure we coordinate our activities, particularly around key deliveries that might impact the local community.

Over the next two months we will:

- Complete works to the intermediate basement slab we call B1 and start to bring walls and columns up to ground level.
- Start to remove the large steel props as the permanent works start to replace the temporary works.
- Our concrete pump and placing boom are now in place. Therefore, most concrete deliveries going forward will be via our Portsmouth Street pit lane.

We will continue to operate within the agreed planning hours with all noise and vibration monitoring in place and active.

As you will have seen we have placed barriers around the site to protect the public and our traffic marshals are on hand to ensure everyone's safety. Please help us by observing the directions of our traffic marshals and for your safety please do not walk in the roads.
